Local Presidents

Did you know that you (or someone else from your local that you send as a designee) can attend the 2017 Summer Leadership Conference for little or potentially no cost?

Special Online Registration Pricing

\$100

Registration fees are prepaid for a president/designee for the Summer Leadership Conference. It is NOT necessary to send payment with registration. Indicate on the form that you are the Local President or designee and include President's Designee form. The registration form (both pages) can be faxed to the number at the bottom of the form.

Upon completion and submission of a Governance Expense Voucher, expenses for local presidents or their designee will be reimbursed based on the following:

- Each local president/designee will receive a \$100 gas/gift card to offset gas costs and bridge tolls. These will be available to sign for and pick up at the registration area Thursday morning.
- Lodging of up to \$120 per night will be reimbursed, with a detailed/zero balance receipt, for two (2) nights (Tuesday and Wednesday). The detailed receipt must include the detail of the charges (room rate, taxes included, etc.) AND show that payment was made and there is a zero balance due. ALL participants are responsible for making their own lodging accommodations.
- Meals are non-reimbursable. Lunches will be provided through the conference and evening meals are on your own.

A Governance Expense Voucher will be given to you onsite; this must be returned postmarked on or before August 31, 2017. A scanned or electronic copy is acceptable. The completed and signed voucher with all appropriate receipts should be sent as soon as possible to Carolyn Cortright at the address listed on the voucher, or to <code>ccortright@mea.org</code>. Because only the overnight rooms for local presidents/designees will be reimbursed, it is suggested that the voucher and hotel receipt be turned in Thursday morning before leaving the conference—when you pick up the <code>gas/gift</code> card.

Reimbursement for contractual lost wages for year-round employees requires appropriate documentation on employer letterhead. It is the president's (or designee's) responsibility to obtain such documentation and it must be submitted with the voucher, postmarked on or before August 31, 2017.

Important Note: Vouchers must be signed and mailed in; electronic copies are acceptable. Keep a copy of the voucher and receipts for your file. Any Governance Expense Vouchers or request for reimbursement of contractual lost wages postmarked after August 31, 2017 will NOT be processed.

Attention New Members/Emerging Leaders

A New Member/Emerging Leader is a member in the first six years of employment in the education profession or involvement in the association who has not previously attended the Summer Leadership Conference. If you are a New Member or Emerging Leader, there is a separate registration fee for you. The fee is listed on page 12 or on the first page of the registration form.

Overnight Accommodations for Participants

Participants are responsible for making their own overnight accommodations.

Participants and presenters are welcome to attend all meals and activities at the Conference. A completed Registration Form is required of all attendees which includes meal choices. Use the separate Activities and Meals Sections on the back of the Registration Form. Please help us make sure there is enough food and refreshments by registering for the meals and activities.

Tickets will be provided to each registered participant for all meals, activities, and sessions. Please note these tickets will be collected for all sessions and functions, so it's important that you keep them with you while at the Conference. If you do not register for a meal or activity ahead of time or change your mind, you can get an on-site ticket based on space availability from the On-Site Registration Area. Likewise, if you register for a meal or activity, and change your mind once at the Conference, please turn in your ticket at the On-Site Registration Area so that it can be used by someone else.

For the 2017 Conference, we will be utilizing LSSU's cafeteria for breakfast and lunch. They offer a variety of options, including a baked potato bar, hot sandwich bar (hamburger, chicken, fish), cold sandwich bar (similar to Subway), various hot meals, and a salad bar. MEA Conference Frequently Asked Questions

Why are the breaks 20 minutes long?

Being on a college campus, sessions are spread out. This allows for walking time.

Why do you need the last four digits of my social security number?

There are multiple records with the same name in the system; it's a way to CONFIRM that the correct member is being registered.

If the record then does not match the information on the registration form, it's an opportunity for MEA to follow-up with the member and get the correct information (name change, address, etc.) in the system.

What is Badge Name or Name to Appear on Name Tag?

This is for members that go by a different name than their given first name, or by their middle name instead of given first name. For example, Debra is the given name but prefers to be called Debbie; Stephen goes by Steve; William goes by Will or Bill; William John goes by John; John goes by Sid, etc.

The given first name should be included in the Name area, then the name you go by would go under Badge Name or Name to Appear on Name Tag.

How do I know if my registration form is received?

As the registration forms are processed, a confirmation email is sent to the email address listed on the form. The typical turnaround time is 7-14 business days.

Are my session/meal tickets really needed?

Yes. Having a session ticket assures those who registered ahead of time have a seat and materials. They are not ALWAYS collected if the session is not full, but you should always have your ticket available when you arrive at your next session.

Meal/reception tickets will also be collected with very few exceptions, so you should make sure to have them with you. The tickets collected are for accounting purposes, this also guarantees accurate food counts.

Can I add/change sessions or change my mind on a meal?

Yes. For sessions, if the session is not full, members are able to change or add a sessions if they are not currently registered. You will be asked to turn in the ticket for the session you are not attending.

Yes. For meal and/or receptions. There may be some restriction, but the conference coordinators do their best to balance having enough on-site tickets available without guaranteeing and paying for too many meals.

How do I add/change/turn in sessions or meals?

Changes can be made at On-site Registration. The staff will be happy to assist you.

Why is the registration deadline so far ahead of the conference?

Advanced registration allows for administrative and inhouse work to be completed in order to meet hosting site deadlines.

Why is the late/on-site fee higher?

Food: No matter where a conference is held, the catering for that location requires a guaranteed number by a specific date; typically one week before the conference. That number can be increased, but once on site, the price will go up.

Why are session sizes limited?

The session size is limited by either the presenters or by room size. Some sessions have material costs which limit participation and availability.

The presenters will limit a session if they feel they need a smaller group because the session is interactive. There could also be a cost to the presentation material, and they need to have a set number of the material and they can't take extra people in the session. The presenters determine the size, not the conference staff.

If I pay a higher fee I should be able to go to whatever session I want—why can't I?

As stated above, if a session is limited by the presenter, those that register timely are guaranteed their preferred sessions.

Registration Process

The option for online registration is once again available. Anyone who pays a fee to attend and registers online whether MEA Member, New Member/Emerging Leader, or pays the Daily Registration Fee amount, will now pay only \$100; as long as you register online. Most of the procedures to document attendance in approved sessions remain the same, that is, until you get to the final step. Please note the following:

- 1. Give your card (SCECH or ESP) to the presenter or facilitator, if one is assigned, when you arrive at your SCECH or ESP Certification approved session. (That way he/she knows you are taking the course for credit.) We suggest you arrive at your session a few minutes before the start of the session:
- 2. Attend the full session;
- 3. Pick up your signed card from the presenter/facilitator as proof you have attended that session for the entire allotted time;
- 4. Return your completed card to the registration area at the end of the conference or before leaving the conference. Due to Michigan Department of Education regulations, ALL SCECH AND ESP CERTIFICATION FORMS MUST BE TURNED IN BEFORE LEAVING THE CONFERENCE. The forms will no longer be accepted via U.S. Mail after the conference.


The International Bridge Bus travels between Sault Michigan and Sault Ontario. The bus picks up and drops off at specific locations on both sides of the border.
