Commissions and Committees: Structure and Oversight Summary

MEA commissions and committees are member-driven advisory bodies established to support the strategic work of the Association. Their purpose is to conduct research, provide informed recommendations, and assist in the development and advancement of MEA's organizational goals.

These bodies are guided by the Representative Assembly and the MEA Board of Directors, ensuring that their work aligns with the Association's mission, values, and long-term priorities. While members lead and carry out the work, they do so within a framework approved by MEA governance.

Membership on commissions and committees is determined through a combination of elections and presidential appointments, as outlined in the MEA Bylaws. Participants bring expertise, lived experience, and diverse perspectives to the work, ensuring that MEA's actions remain grounded in the voice of its members.

The governing documents do not explicitly assign roles for staff on commissions or committees. The only reference to non-member involvement is the provision for liaisons who *may be appointed* by the MEA Board of Directors. These liaison roles may include retired members, students, or staff, as appropriate and approved.

In essence, MEA's governance structures — whether short-term task forces or standing commissions — serve a unified goal: to support organizational alignment, strategic policy-making, and improved outcomes for educators, members, and students.

I. General Information

A. Who guides the work?

1. MEA Representative Assembly & Board of Directors

- Commissions and committees are authorized and guided by the Representative Assembly (RA) and, by extension, the MEA Board of Directors.
- Commissions exist to conduct ongoing study and make recommendations to the RA or Board. Their function is advisory and supervisory, not independent decision-making. ([MEA Constitution, Article VIII](#))
- The Board of Directors may assign specific charges, approve commission plans, and appoint liaisons.

B. Who does the main body of the work?

2. Member-Driven Participation

- a. While the Board guides the structure and charges, the work itself is carried out by members—through elections, appointments, and active service.
- b. The Bylaws specify that members:
 - Elect commission representatives (six per commission)
 - Submit petitions for candidacy (minimum 15 delegate signatures)
 - May be appointed by the president with Board approval

"Each commission shall conduct such continuing studies, investigations, and/or programming as is necessary to carry out the functions assigned by the Representative Assembly or the Board of Directors." ([MEA Constitution, Article VIII](#))

- c. Summary: MEA commissions and committees are member-driven bodies empowered to study, advise, and support strategic priorities. Their work is guided by the Representative Assembly and the Board of Directors, ensuring alignment with MEA's mission, values, and organizational goals.

C. What is the role of the officers in the commissions and committees?

(from Article VI of MEA Bylaws):

1. President

- a. Membership and appointment
 - The president shall appoint commission members with consent of the Board, except those elected by the Representative Assembly (not to be delegated).
 - The president shall serve as ex officio member on all commissions and committees.
- b. Vacancies
 - The president, in consultation with the Board, fills vacancies on commissions—whether a Board-appointed vacancy or one originally filled by RA election—until the next Representative Assembly session.

2. Vice President's Role:

- a. The vice president shall chair committees and task forces at the discretion of the president.
- b. The vice president also serves as an ex-officio member on all commissions and committees.

Note: The vice president does not appoint commission or committee members—that responsibility lies with the president, with Board approval.

3. Secretary-Treasurer's Role

- a. The secretary-treasurer shall be a member of all official budget-related committees.
- b. The secretary-treasurer shall chair committees and task forces at the president's discretion.
- c. The secretary-treasurer shall meet periodically with appropriate staff—as agreed with the president and executive director.

D. Summary of CCCTFs

- 1. Ex officio membership
 - The vice president and the secretary-treasurer are automatically non-voting members of all committees and commissions (unless granted voting rights separately). This ensures continuity, institutional memory, and a governance link.
- 2. Chairing Authority
 - At the president's discretion, the vice president and secretary-treasurer may be selected to chair specific task forces or committees—supporting strategic alignment and leadership where needed most.
- 3. Coordination & Oversight Role
 - While the president officially appoints commission members and chairs (with Board consent), the vice president's ex-officio and chairing functions make them an essential bridge between governance and member-led bodies.
